PRESIDENT: Are there any bills for introduction?

CLERK: None, we have some more committee reports Mr. President.

PRESIDENT: Read the reports.

PRESIDENT: While the legislature is in session and capable of transacting business, I'm signing LB343 and LB674, LB690, LB849, and in addition thereto 1122, 1123, 1162, 1163, 1173, 1194, LB1216

SENATOR LUEDTKE: I move that LB, the E & R amendments on LB1095 be adopted.

SENATOR LUEDTKE: I move that LB1095 be advanced to E & R for engrossment.
