PRESIDENT: The Chair recognizes Senator Waldron.

SENATOR WALDRON: Mr. President, this amendment that I would have proposed here is brought in by the Secretary of State. We have gone past the filing deadline and Senator Duis felt that he had some problems in his district with people filing under the old law or under the new law so this will take care of that problem and it is just a simple amendment. It will not change the basis of the bill. And so I would move that we return it to Select File and adopt this amendment which changes the election procedure here so we will be in compliance whether they file under the old law or under the new law.

PRESIDENT: You have heard the motion with the support. All those in favor of returning 1168 to Select File for a specific amendment vote aye. All those opposed vote no. The motion is to return the bill to Select File for a specific amendment. Have you all voted? The Clerk will record the vote.

CLERK: 36 ayes, Mr. President, no nays.
